The New Open Insurance Report

The new Open Insurance Report offers powerful features that allow you to report outstanding items to which insurance has not responded. This information will facilitate taking specific measures for collecting on these items, such as rebilling charges or contacting an insurance company.

A key feature of the Open Insurance Report is choosing to show open insurance items for both primary and supplemental insurance companies. The user may also choose to automatically reflag items included on the report, making it even easier to rebill nonresponded charges.

The Open Insurance Report employs a new convention for choosing report parameters: *(continued on the back)*

Medicare Electronic Summary Report

The Avanta system now has the ability to receive and view Error Summary Reports (ESR) that are electronically sent from Medicare. The ESR includes summary information regarding how many items are being processed and rejected for a given claim file. To receive and view ESRs from Medicare:

1. Press **[6]** Insurance Billing/EDI from the home screen.

2. Press [2] Medicare Electronic Billing.

3. Press [A] Get New Files from Medicare. The system will initialize the modem, dial Medicare's number, and retrieve any files available on Medicare's electronic Bulletin Board system.

4. Press [B] View Files Received From Medicare.

5. Select the number or letter of the ESR file you wish to view.

The ability to receive and view Medicare ESRs will be added to your system with your next update. To begin receiving ESR files, please note that you must first fill out and send in the signup form to Medicare. If you need an ESR signup form sent to you, or if you have questions about the Medicare ESR, please contact Avanta.
