

# Automatic Medicare EOB Posting is Here!

The Medicare electronic EOB posting feature is now here! Your next Avanta update will allow you to receive your Medicare EOB electronically over the modem and have the payment, write-off and deductible information automatically posted to patients' ledgers.


This feature is already in use at several offices and they are delighted with it. For example, at one office a multi-page EOB totalling \$40,000 used to take almost a day to post. The new program posted it in only two minutes, with almost 100% accuracy. The program generates an error report that lists any items that cannot be electronically posted.

Medicare requires all submitters who want their EOB received electronically to complete and sign an authorization form. This form is available from Avanta and can be faxed to you upon request. After the authorization form has been filled out and sent to Medicare/NHIC, and your Avanta update completed, you're ready to go!

# ProxyMed Update

As many of you know, last fall certain disputes arose between ProxyMed and Avanta regarding the billing and other details associated with the handling of your third-party (non-Medicare) electronic claims. While we have

endeavored to enter into an appropriate agreement with ProxyMed, unfortunately we have not been able to negotiate an agreement with them that we believed would be in Avanta's and our clients' best interests.

Consequently, no business relationship currently exists between Avanta and ProxyMed. This means that you must deal directly with ProxyMed regarding any contracts, pricing, billing, sign-up and other business-related matters.

We will keep the current version of the Avanta-to-ProxyMed electronic claims capability in the Avanta system for the near term. Longer term, we are investigating an association with an alternative vendor so that we can offer you a more integrated third-party billing solution than appears to be possible with ProxyMed.


After six weeks of "living" in temporary space, we have finally settled down into our new office. We thank you for your patience and apologize for any inconvenience you may have experienced.

The next time your terminal freezes for no apparent reason, try typing "CTRL-Q" (hold down the "ctrl" key and press the letter "Q") to release it. About 70% of all frozen terminal cases are caused by an erroneous sequence of keystrokes that sends a data flow lock to the server. In most cases, "CTRL-Q" will fix it.
